  - There were no public comments

### Board Member Reports:

- Board Member Prater reported the RV Park is currently installing Solar Panels. They are busy with RV groups coming in as soon as the last group leaves.
- Board Member DeLorenzo reported golf season is winding down. High Schools are finishing up their seasons. They still have a few events scheduled - a US Kids event in December and a Ladies Invitational with over 60 ladies participating. Currently selling annual passes for next year - coupons on Groupon and Golf Moose.
- Board Member Turner reported the Wine Mural on 5<sup>th</sup> street is almost complete. There will be a ribbon cutting at 5:30 this Tuesday. Check it out!
- Board Member Tucker reported there is an upcoming study session on traffic, housing and the sports park on 10/29. Council received data on 4<sup>th</sup> of July fireworks (legal & illegal). Citations have been issued with fees of \$1000.00 for illegal fireworks. Measures the fire chief has put into effect are working.

- Board Member Heath reported he is currently working on a business & operational plan
  to submit to council to hopefully redesign & update the building. He recently launched an
  after-school program funded by a grant from the Gilroy Foundation. Dia de Los Muertos
  exhibit is now open. They will be hosting an open house on 10/27 from Noon 4pm.
  Holiday Boutique coming up first week in November. Limelight Theater is a finalist for
  three awards through Theater Bay Area. First theater (south of San Jose) to ever be
  nominated for this award.
- Board Member Vanni reported they are in the middle of Harvest. Today they are harvesting their Sangiovese. Library tastings starts immediately after Thanksgiving.
- o Board Member Brownlow reported EDC continues to receive inquiries about available properties. EDC recently received a request for information on a proposed new movie theater. New Distribution Center (Performance Food Group) will be relocating here with some potential job opportunities. Sumano's Bread Company from Watsonville will also be relocating to downtown on Monterey Street south of the transit center. They are hoping to have a retail portion open to the public. Specialty Parts out of San Jose is moving into the RAP4 building on Arroyo Circle. EPS analysis of key opportunity sites in Gilroy should be completed and available by the end of the month.
- Board Member Sanchez reported the restaurant business is very good right now. All the
  local downtown restaurants really benefited from the recent Tamal festival downtown.
   Several restaurants have signed up for California Restaurant Month in January. That
  month is a slower time for restaurants and this promotion will hopefully drive more
  customers into local restaurants.
- Board Member Gebhardt reported Hampton Inn should be open sometime in March
   2019. Lodging projections for 2019 continue to look positive.
- Board Member Roach reported all the exterior painting at the center has been completed. Finishing up on some roof improvements and paving projects. Landscaping projects will be next. Trick or Treating on 10/31 from 3 5:30. GPO is expecting around 700 kids this year.
- Board Member Patel reported Best Western occupancy has been steady. Increase for next year should be very minimal.
- September Social Media, Marketing & PR Report Kat Filice & Jason Raby from Articulate
  Solutions reviewed the monthly social media campaigns. Visit Gilroy website traffic is up 25%
  over last year. Mobile traffic is trending at 75%. Visit Gilroy website won another award in
  addition to Solis Winery. Marketing to Canada will have a (.org vs. .com) for purposes of
  tracking domestic vs. international.
