December 2020 Google Analytics & Monthly SMP Reports – Jason reported Traffic was up 55% over prior year due to Phase 2 of the Support Gilroy campaign. Top source of traffic into the website was the Google AdWords campaign for Support Gilroy followed by organic Google search traffic. Tablet traffic is about 15% taking away some of the desk top systems. Average session duration is down YOY also due to Support Gilroy campaign pushing traffic out to other pages on the website. 51% of Blog traffic is coming from organic searches. Top sites on webpage are Support Gilroy, Home Page, 33 things to do and Restaurant page. There was a ½ page ad in Gilroy Life in December. Did a lot of reposting and resharing posts on Facebook & Instagram?

Recap on Phase 2 of Support Gilroy campaign (November 24 – December 31) \$10,000 was used to promote Gilroy to Gilroy residence! Goal was to Educate, Encourage & Unite! The Support Gilroy Landing page linked to all the different business listings (shopping, restaurants, wineries, etc.). Ads ran in both English & Spanish. 14 ads total! Surpassed goals that were set for this campaign.

May 2020 – Dec. 2020 Strategic Marketing Plan Recap – Even though goals were readjusted, and budgets have been revised due to COVID-19, still surpassed our metrics for the year. Did launch the blog in 2020. Most popular blog was a 30-minute Garlic Shrimp recipe.

GEDP Status Report – Mark Turner reported there was no December meeting, however the City of Gilroy extended the deadline to submit proposal for 536 project to 2/12/21. On January 11th, the Gilroy City Council heard the presentation from the GDBA about the Gilroy Gourmet Alley Project. The Sharks Ice Project - the city council ad hoc committee is looking at return on capital investments, sales tax impacts, ongoing operating costs, profit margins, non-direct economic impacts such as gas station, hotels, restaurants. Gilroy & Morgan Hill chambers have been meeting once a month and working on issues for South County. Working on 3 initiatives
