March 2021 Google Analytics & Monthly SMP Reports – Jason reported 37% increase in users YOY. Google Organic traffic was top contributor for the month with most of that traffic feeding into the home page, 33 Things to Do page and hotels and wineries. We did have 199 blog visits. Currently running 2 digital campaigns. 1) TBID one focusing on general hotel stays and wedding interests. 2) City funded campaign focusing on outdoor recreation, shopping, wineries, restaurants, Gilroy Gardens, golf. Next month we will be starting a digital campaign with Visit California & Expedia. For a \$10,000 buy in, we receive \$26,000 value. We will play off the "What If" campaign that Visit California is using. A full-page co-op ad in the South Valley Visitor Guide coming up in mid-May. There was also a co-op with CCTC that started in April. Submitted 3 different story ideas to Visit California. 2% increase on our Instagram page. We have updated our visitor map and are working on a new brochure rack card.

GEDP initiatives update - discussion & possible action (536 proposals) \*

The City of Gilroy released the press release on the evaluation process for the 536 Proposals in early March. There were Two companies (Imagine That & Select Contracts) that submitted proposals and the in-depth interviews were conducted by representatives from The City of Gilroy, Economic and Planning Systems, Chamber of Commerce, Visit Gilroy, and Gilroy Gardens on April 9, 2021. Based on the recommendation from the Visit Gilroy board of Directors, we suggest that the City of Gilroy enter an ENA (Exclusive Negotiating Agreement) with SELECT CONTRACTS based on meeting all the criteria set forth.
