May 2021 Google Analytics & Monthly SMP reports. On our website, we were just shy of 31K visitors and 53K page views. Stats are much higher than 2020 numbers. Digital campaign with google ad's & organic searches are contributing to those website numbers. 70% of traffic is coming from mobile devices. Top 4 pages are the Home Page, 33 Things to do, Shopping, and Hotels. Comparing these numbers with 2019 and removing the digital campaign, we are below 2019 numbers. We did build a new website in 2018 so those numbers would be a bit sku'd. Advertising – submitted several banner ads to Certified Folder for posting on their website as part of the rack card program. Submitted an ad in the City of Gilroy Recreation Guide with the "Stay Curious" message. Submitted GMH (July – Sept.) issue, focusing on our Freedom to Travel and educating people on the importance of tourism and how that helps with the economic recovery. Submitted the last of our year long ads with CCTC. Social Media significant increase in impressions. Most viewed was Santa Clara Wine trail and wineries being open for business. Facebook impressions were over 500,000. Most popular post was Memorial Day weekend talking about the Farmer's Market and Shopping at the Outlets. June is the last month for city funded digital campaign. Ads still performing well. Jason will recap next month.

Old Business -

CWC Operations Update – CWC manager, Pam Gimenez reported for the first time in over 13 months the Welcome Center had over 1000 walk-ins. The center continues to be busy with retail sales and walk-in visitors. Some new product has been ordered and we are awaiting delivery. Gilroy Gardens tickets have been delivered and CWC Gilroy is selling them for \$32.99.

Tourism & Community Engagement Coordinator job description – ED Howard reviewed some slight changes to the job description - adding the writing of blogs for the VG website in coordination with VG marketing agency. Also, the job description reflects a decrease in weekly hours from 35 to 30. Plan is to fill this position by 10/1/21. ED Howard will offer this position internally first to see if any of our current P/T staff may be interested. If not, then will post the position in mid - August.

New Business -

Operations Budget FY21/22 Draft - Budget assumptions include Dedicated Internet Access upgrade; Reset Salaries for Executive Director & CWC Manager to pre-pandemic rate; increased rent and hourly increase to \$15/hour for current part-time staff.

Website Accessibility ADA Compliance Report – Options sent to the board prior to this meeting. Katherine Filice from Articulate Solutions explained that websites are considered "public accommodations" and thus are required to comply with the ADA. The Web Content Accessibility Guidelines (WCAG) provide some recommendations for making websites and online content more usable and navigable for all users including those with hearing, vision, motor, and cognitive conditions. There are 3 levels of conformance. Level A (minimum); Level AA (medium) and generally considered the target level of accessibility to meet legal requirements; Level AAA (highest) and exceeds accessibility requirements. If you do not follow these standards, you could potentially leave your organization vulnerable to lawsuits. There are four steps in the accessibility process.

- 1. Initial Site Audit
- 2. Remediation
- 3. Final Site Audit
- 4. Maintenance

Discussion as to how much this organization is able to spend and what option is chosen. ED Howard spoke to an attorney who specializes in ADA regulatory compliance and was told that this organization would "probably" be lower risk, however, we are at risk being a taxpayer funded organization. ED Howard reported the board has 3 options:

- 1. Do nothing and wait it out,
- 2. Automated Audit & Remediation (not to exceed \$10K) (30 40% of WCAG items addressed)
- 3. Establish a two-year action plan to address ADA compliancy issues setting aside money in the budget for that and in the meantime, install a hearing-impaired phone line at the center with a special number.

Motion to Proceed with a Hybrid Option B & C with Automated Audit & Remediation with a 2-year plan moving forward including a hearing-impaired phone line for the CWC Gilroy.
