- October Social Media, Marketing & PR Report Jason Raby reported website traffic overall was down 18% YOY. After taking out the Sweet Retreats digital campaign from last year, traffic was up 12% over prior year. Mobile traffic is 73.4%. Top pages viewed: Gilroy Gardens Halloween was top page viewed followed by 33 things to do, Visit Gilroy homepage & then beer crawl.
 Facebook impressions are up 34% with the top post engagement being the Tamale festival.
- Consent Calendar Approval of October 17, 1029 board meeting minutes and Approval of October 2019 financials – MSC approved unanimously.

New Business

- Visit Gilroy Destination Perception Study Proposal Board discussed if Visit Gilroy should do a Perception Study vs. an NPS study or a combination of the two. After discussion, board asked ED Howard to "fine-tune" the proposal and draft questions to bring back to the board of directors in January 2020.
- Visit Gilroy 2020 GTBID Annual Marketing Meeting & Budget Draft after some discussion, the TBID committee recommended a conservative amount for projected income for 2020. With Hampton Inn coming on board in first quarter 2020, they believe the RevPAR will see a decrease of about 3%. MSC Approved unanimously.
- Tourism & Community Engagement Coordinator job description MSC approved unanimously for ED Howard to begin the process for hiring with a target date of February 2020.
- City of Gilroy Lodging Report Qtr. Ending 9/30/19 is not yet available. We will forward to the board as soon as it becomes available.

- Visa Vue Travel Reports Domestic & International Qtr. Ending 9/30/19 copies distributed to the board of directors. Both Int'l and Domestic spending is down.
- FY 17/18 Gilroy Visitors Bureau 990 tax return copies distributed to the board of directors.
- Visit Gilroy board of Directors vacancies board directed ED Howard to reach out to several categories including artists to see if they would be interested in joining the board and Casa deFruta RV Park.
